CSEM Sales Scripts for "Hidden Risk Audit" Campaign

(Leveraging Cialdini's reciprocity + Belfort's pattern interrupts + Hormozi's value anchoring)

SMS Outreach

Hook:

"John, OSHA just fined 3 [Industry] companies \$127K last week. Free audit shows your hidden risks → [LINK]"

Body:

"We'll find gaps you can't afford to miss. Reply STOP to opt out."

Voicemail Script

"Hey John, Heath from CSEM. Saw your plant expansion news – congrats! But here's the thing: 83% of growing manufacturers get hit with surprise OSHA fines their first year. We just helped [Local Company] dodge \$58K in penalties. Check your inbox – I'm sending our Hidden Risk Audit invite. No pitch, just proof. Talk soon."

Assistant Version:

Subject: "Heath's OSHA Audit Invite for [Exec Name]"

Cold Call Script (Human)

Jessie: *"John? Jessie from CSEM. Quick question – when was your last full OSHA audit?"*

Prospect: *"6 months ago."*

Jessie: *"Perfect timing. We're finding new silica rules are catching 3/4 of [Industry] teams off guard. Before you get hit, let's do a free Hidden Risk Audit. Takes 90 minutes, zero cost. Heath has Tuesday at 10am – want me to lock that in?"*

Objection Handler:

"Not ready yet" → "Exactly why we do this – 58% of fines hit 'ready' teams. Worth 15 mins to check?"

AI Agent Script (Inbound)



"This is Jessie from CSEM! 📍 Before you hire more safety staff, our Hidden Risk Audit shows exactly where you're exposed. Last month we found \$4.7M in preventable fines for companies like yours. Want me to schedule your free audit? (Heath's next slot is Tuesday 10am...)"

"What to Expect" Video Script

[B-ROLL: CSEM team working]
